- ❖ Whereas a large section of the students who had appeared the above mentioned examinations and had approached the University with a request to arrange for 'Special Checking – Post Review' of their already reviewed answer papers.
- ❖ Whereas the University administration had responded to their appeal and accordingly had issued a Notification dated 25.06.2024 which allowed those students to apply for 'Special Checking – Post Review' of their answer scripts.
- ❖ Whereas the process of 'Special Checking – Post review' is complete, outcome of which is published by now and mark sheets for same has already been prepared by the University.
- ❖ Whereas it is understood and evident that taking this special arrangement and goodwill gesture by the University administration was just to ensure that student's concern is addressed properly with utmost transparency.
- ❖ Whereas it appears that a section of these students are still not convinced as they had raised grievance lately and after publication of results for 'Special Checking – Post Review'.
