



## III. Execution of the Agreement:

The Specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

## IV. Term and expiration of the Agreement:

It is understood that this agreement will come into effect after being signed by both parties and will be established for a period of three years. After these three years it will be automatically extended for same period, under one of the parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MOU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the parties.

Any additions, changes, or deletions to this document must be approved by the representative of both parties. All notices shall be in writing and shall be directed to these representatives.


## V. Non-Exclusivity:


The Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.
